Sub: Scrutinizer's report with respect to voting by Equity Shareholders carried out through e-voting and remote e-voting.

1. The Company had appointed Central Depository Services (India) Limited ("CDSL") as the agency for providing remote e-voting platform to the Equity Shareholders of the Company and necessary technical support was provided by Maheshwari Datamatics Private Limited, the Registrar and Transfer Agent ("RTA") of the Company, for processing e-voting and remote e-voting.
2. The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, rules framed there under and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to e-voting and remote e-voting of the Meeting on the resolution contained in the Notice dated January 22nd, 2026.

My responsibility as a Scrutinizer is to ensure that the process of voting by way of e-voting and remote e-voting of the Meeting was conducted in a fair and transparent manner and to submit a Scrutinizer's Report on the voting to the Chairperson of this Meeting on the resolution contained in the Notice dated January 22nd, 2026, based on the report generated from the electronic voting system provided by CDSL.
4. The Cut-off Date for the purpose of determining the Equity Shareholders entitled to vote through e-voting and remote e-voting of the meeting was Friday, February 13th, 2026. As per the provisions of the Companies Act, 2013, the number of votes cast in respect of the resolution have been counted according to the number of shares held by the concerned Equity Shareholders.
5. The Company had completed the dispatch of Notice of meeting of Equity Shareholders dated January 22nd, 2026 to those Equity Shareholders whose name appeared in the Register of Members / List of Beneficiaries, as received from CDSL, on the Cut-off Date being January 16th, 2026.
6. An advertisement was published in English in "**Business Standard**" and translation thereof in Bengali in "**Arthik Lipi**" in newspaper on January 28th, 2026 informing the Equity Shareholders about the meeting and the resolution proposed thereat.
7. The remote e-voting commenced on Tuesday, 17th February, 2026 at 9.00 A.M. (IST) and concluded on Thursday, 19th February, 2026 at 5.00 P.M. (IST). The Equity Shareholders who were holding shares of the Company, as on the Cut-off Date i.e. Friday, February 13th, 2026, were entitled to vote on the resolution set out in the notice dated January 22nd, 2026.
8. The remote e-voting module was disabled by CDSL for voting on Thursday, 19th February, 2026 at 5:00 P.M. (IST).

9. The remote e-voting module was activated by CDSL from 12.30.P.M on Friday, February 20th, 2026 and was deactivated at 1.15.PM on Friday, February 20th, 2026 as per the instruction of the Chairman of the meeting.
10. On Friday, February 20th,2026 at 1.50 P.M. (IST), I have downloaded the e-voting report from the CDSL website.
11. The votes cast by the Equity Shareholders through remote e-voting facility were scrutinized by verifying it using the Scrutinizer's login on the CDSL e-voting website.
12. Particulars of e-voting and remote e-voting received by the Equity Shareholders have been entered in a Register separately maintained for the purpose.
13. At the meeting convened the Chairperson after discussion on the resolution mentioned in the said Notice announced that the Equity Shareholders present at the meeting who have not casted their vote by remote e-voting, can exercise their voting rights through e-voting at the Meeting.


